The following documents shall not count towards providing valid proof of family income
- affidavits, letters issued by private employers, bank account statements unless corroborated.

Note: Submission of the form along with supporting documents is mandatory for consideration of award of Freeship. Continuing students have to explain the detailed reasons of changed circumstances under which they should be considered eligible for freeship. It will be matched with the data of earlier application.
