The application for SAU freeship should be accompanied by the documents that disclose the total family income such as:

- a) Income tax returns
- b) An income certificate issued by the concerned government body (or agency authorized to issue income certificate) that clearly states the total family income with name and stamp and contact number.
- c) Any other document which is approved by a government agency/body/official that clearly states the total family income with name, stamp and contact number.

The following documents shall not count towards providing valid proof of family income  
- affidavits, letters issued by private employers, bank account statements unless corroborated.

Wrongful disclosure of family income, concealing any material fact pertaining to family income or submitting forged documents may attract strict disciplinary action. The committee may refer such matters to the proctorial Committee.

**Note: Submission of the form along with supporting documents is mandatory for consideration of award of freeship. Student who is availing any scholarship/salary/financial assistance from any source shall not be eligible for SAU freeship.**
